Mike Costell built a "Stepping Block" in front of the Church where the ladies, mounted on horses, could dismount. Wagons, buggies and still later, cars, parked all over the front yard.

The silver communion goblets were donated by Mrs. Carrie Smith Nelson; as of 1962 they were in the possession of Mrs. B. M. Ware. The Goblets are now on display in a cabinet in the Narther (1998)

The impact of the War Between the States. the Civil War, upon Methodism in Georgia was devastating. In Georgia, no session of the annual conference failed to convene, but due to disorganization its work suffered: no statistical reports could be made; travel to and from the site was restricted due to disturbed conditions; communications had been disrupted and the need for the men to stay at home and in their individual communities was evident.

Bishop John Early had been scheduled to preside at the 1863 Conference, but he could not be present.

Preachers matched patriotism with the laity as enthusiasm prompted general enlistment in the Confederate Army. Some preachers had enlisted as soldiers. The appointment system (assigning preachers to their churches for the next year) was complicated, because of the absence of many preachers, who were in the service. Preachers remained where they were for another year.

The thrill of victory; the depression of defeat; the disintegration of business; the anxiety for loved ones in uniform and the destruction of family life were combined forces against the Church. Public worship was neglected; Sunday Schools disbanded and some churches were burned to the ground as acts of war and pillage.

Christian experience began to lose its fervor; Sabbath desecretion, public swearing, dishonesty, gambling and

licentious living told the story of moral deterioration. Church leaders called for richer personal experiences in Bible studies, individual devotions and regular attendance upon public worship on the part of members. Sins of all kinds were exposed and vigorously reproved. Gratitude to God, love of country and a zeal for souls urged the spiritual laborers onward.

Atlanta, Georgia, surrendered to General Sherman's federal forces on September 2, 1864. The surrender of the Confederate Army took the people at home by surprise. The true state of things at the front was kept from the people, who were visualizing victory, believing in the right of the Southern Cause and that God was on their side. And now, S-U-R-R-E-N-D-E-R!!

The bitter humiliation of defeat was felt! Had God betrayed the Southern people, who had trusted Him? Faith of the Southern people grew feeble and they had to struggle to keep it alive. The whole outlook was dark--dismally so; the political, economical, domestic and religious patterns of life were out of balance.

The Methodist Episcopal Church, South rallied! Gradually the members accepted that it was their misunder standing of God's truth and not God's infidelity to His word. Confidence was restored; faith was renewed, while a new day dawned.

The Georgia Annual Conference had become so large as to warrant a division. It divided into two annual conferences: The North Georgia Annual Conference and The South Georgia Annual Conference. The dividing line went across the State of Georgia, east to west. The line was drawn just north of Macon and just south of Gray.

The General Conference of 1866 (composed only of preachers) recognized that the time had come to recognize laymen in the various phases of activities in the Annual and General Conferences of the Church. Laymen were limited to

their own local charges, or churches, for they had no membership in either the annual, or general conferences, nor did they participate in the work of these conferences. The integration of the laymen into the life of the Church in an organized manner was not instantly successful, nor a complete success.

Appreciation of these laymen and their contributions to the growth and development of the Christian endeavors within the various levels of conference activities grew as time, again and again, proved the wisdom in this case to be right. More and more responsibilities have been allocated to the faithful laymen through the organization of the General Board of Lay Activities and its comprehensive programs and varied interests. Today, 1999, the Laymen answer the call to conference leadership and encourage others to be equally as faithful.

The horrors of Reconstruction of government and society were more demoralizing than the war. The breaking up of large plantations into small farms and the reaction of the blacks to their freedom left much to be desired. The desolations of the war left the people brooding over altered fortunes; a paralyzing sense of total disaster followed the end of the war. These bleak situations were issues that the Church had to face for they had the tendency to drive the peace of God from the hearts of the people. Many preachers had no horse, were without a parsonage and received meager support for their efforts. These men, however, appeared to be happy, rejoicing in the work given to them.

The General Conference held on May 23, 1878 at the First Methodist Episcopal Church, South in Atlanta, Georgia, authorized the Woman's Foreign Missionary Society to become a regular institution in the Methodist Episcopal Church, South. This date was a historical one for the women of the Church. To safeguard this authorization, the bishops

appointed all the officers; they appointed their own wives as vice presidents. The Woman's Home Missionary Society of the North Georgia Annual Conference of the Methodist Episcopal Church, South was organized in Marietta, Georgia, on November 30, 1878.

On November 11, 1918, Germany and the Central Powers surrendered and signed the peace treaty, called the Armistice.

The General Conference of 1918 was held in Atlanta, Georgia, at the Wesley Memorial Methodist Episcopal Church, South. At this conference a vote of 265 to 57 was taken granting "Laity Rights" to the women of the Church, that is to share in the conference business and activities as the men had been doing for fifty-two years. Up to this time, their voices could not be heard. However, there was still much unfriendliness toward the women's work in the Church.

Undauntedly, the women of the Church assumed their places in the organization of the local churches, in the districts, and in the annual and general conferences. Reviewing their important roles as of 1999, it is clear the women of the Church have been most influential in determining and in promoting the great movements of Methodism in our nation and throughout the world.

The Turin Circuit consisted of four churches: Turin, Mount Gilead, Bethel and Cokes Chapel.

Penicillin was discovered in 1928. The most devasting disease was polio. It was a fearful disease as there was no cure. Polio left its victims crippled for life, in iron-lungs for years, or dead. There was another disease almost as dreadful. It was Tuberculosis. People thought going to a dry climate was the answer, but the chances for recovery were between slim and none, regardless of what care one received. Confinement and isolation faced the patients.

During the 1920s, the average annual income was about \$1,000.00 per family. Only those earning \$3,000.00 or more could afford to hire domestic servants. By this time, 1929, about 60 per cent of the homes had electricity and some of the new-fangled, labor-saving appliances were appearing as part of the domestic scene. The electric iron was a best-seller.

"The Great Depression" began in the United States of America during the fall of 1929. The workers were laid off from their jobs; factories and businesses folded; money became scarce, banks closed, and a state of near panic seized the people. The Church, in addition to meeting the spiritual needs of the community, now faced the task of meeting the material needs of the people: food, clothing fuel, etc. People were called upon to look out for one another; they shared. These times brought the people closer together.

At the 1937 Session of the North Georgia Annual Conference, Mrs. R. M. Paty addressed the conference on the second day, during the morning session. She spoke feelingly on the conditions prevailing in China due to the Japanese invasion. The conference received an offering of \$745.00, which was designated "For the relief of the Chinese."

The American people became very conscious of the atrocities of the Japanese upon the Chinese people. Response to this struggle of the Chinese to drive the enemy from their shores aroused some American men to enter the warfare on the side of the Chinese.

The Uniting Conference was held in Kansas City, Missouri, on April 26, 1939 through May 10, 1939, in which The Methodist Protestant Church, The Methodist Episcopal Church and The Methodist Episcopal Church, South, were mlerged into one Church: THE METHODIST CHURCH. Among the changes made, the following names were changed: Presiding Elder became District Superintendent; the Woman's Missionary Society became the Woman's Society of Christian Service; the ladies who worked were organized in the Wesleyan Service Guild, and the Epworth League became the Methodist Youth Fellowship.

During the Depression, desertion (husbands and fathers left their families to forge for themselves) soared in our nation. Divorce rates dropped. Half of the births were in families on relief, or making under \$1,000.00 per year.

On December 8th, the Congress of the United States declared war on Japan. On December 11th, Germany and Italy declared war on the United States. It became a war between the Allied Forces (the United States included) and the Axis Forces, including Germany, Italy and Japan. Cokes Chapel had snew member, for Todd, who was stationed at Pearl Harbor Solace.

The civilians faced the ration cards for such items as tires and gasoline for the cars; meat, coffee and sugar for the table and clothing. New titles of music reflecting the times: "Rosie the Riveter," "Victory Gardens," and "USO," Then there was leg lmake-up to replace hosiery and V-Mail.

He persuaded the reluctant United Nations to approve his action and fifteen nations joined America in battling North Korea and China. Fighting erupted at the 38th parallel in Korea on June 25, 1950.
